SUBSTANCE ABUSE RECOVERY PROGRAM IS A NONMEDICAL DETOX UNIT AT THE MEN'S AND WOMEN'S CENTERS. MORE THAN HALF OF THE HOMELESS POPULATION IN THE UNITED STATES SUFFERS FROM ADDICTION TO DRUGS OR ALCOHOL. THE MEN'S RECOVERY PROGRAM SERVED 173 MEN, THE WOMEN'S RECOVERY PROGRAM SERVED 63 WOMEN IN 2016. FOLLOW UP STUDIES INDICATE THE MEN HAVE A CONTINUED SOBRIETY RATE OF 65% AT ONE YEAR WHILE THE WOMEN MAINTAIN A 70% SOBRIETY RATE.

THE HOPE CENTER'S PSYCHIATRIC AND SOCIAL SERVICES ALSO EXTEND TO MANY MEN AND WOMEN RESIDING ELSEWHERE IN THE COMMUNITY. SERIOUS AND PERSISTENT MENTAL ILLNESS IS WHAT KEEPS AS MANY AS 25% OF ALL HOMELESS PEOPLE LIVING ON THE STREET. THE MENTAL HEALTH PROGRAM PROVIDED AN AVERAGE OF OVER 2,000 SERVICES EACH MONTH.
